



Standard TERMS AND CONDITIONS OF WEBSITE USE

1. This website is operated by *Neurosoft*, of 466 Irakliou Ave. & Kiprou, 141 22 Iraklio Attikis, Athens, Greece (the 'Neurosoft or organisation'). *Neurosoft*, through its website, enables the Internet visitor/user to be informed about the organization, its products and services. Please, read carefully the following Terms of Use.
2. Any *user of Neurosoft's* website accepts unreservedly, by using the site, the terms and conditions for its use as set out here. These terms include the legal jurisdiction within which any legal issues arising from the operation of the site may be addressed. Any person who does not wish to accept these terms and conditions or who knows, or ought to know, of any reason why these terms and conditions might not be capable of applying to their purposes, is not authorised to use this site. These terms apply to each and every visit that a *user* may make to this site.
